With our new General Secretary Marcin Barankiewicz, we have a profound expert on the subject at our side, who, as the successor to Jordi Brunet, has delivered his masterpiece with the organization of the GA in Gdansk.

May the 15th was a significant day for Independent Service Providers. Regional Court of Cologne rehear a Carglass@ Germany/Belron@ATU against FCA (Stellantis) considering the European Court of Justice (ECJ) decision from the 5th of October 2023. The ruling was in favour of Carglass@ Germany/Belron@and ATU. It confirmed that Independent Service Providers need to have access to in-vehicle data and conditions for access other than those provided in 2018/858 Type-Approval Regulation are forbidden.

In the previous EGEA Inside, we presented the case background. The Regional Court of Cologne forwarded questions to the ECJ on how to interpret the 858 Type Approval Regulation. ECJ made a legal interpretation, which is why the case returned to the Regional Court of Cologne's docket.

GROUNDBREAKING DECISION

"The ECJ's decision is nothing less than groundbreaking for the independent aftermarket. The Court clearly stated that any conditions attached to access to the vehicle data stream are unlawful unless they are expressly provided for by law – and the law does not allow manufacturers to block their OBD ports. The practice introduced by many manufacturers of restricting access by using „secure gateways“ or similar mechanisms must be abandoned immediately. Independent workshops must be able to access the vehicle data

stream through the OBD port without any restrictions (this includes access fees, by the way). The Regional Court of Cologne, where the proceedings had their origin, has already ordered one manufacturer to comply with these principles. Other manufacturers will follow" said Elisabeth Macher, L.L.M, Counsel from Osborne&Clarke Law Office representing Independent Service Providers.

Work is currently underway in the European Commission on the delegated act to amend Annex X of the Type-Approval Framework Regulation. ECJ decision is taken into account in these works to ensure the access of independent operators to on-board diagnostics (OBD) and repair and maintenance information (RMI) in line with Art. 61

EGEA is part of the Independent Service Providers alliance fighting for unhindered access to vehicle data for independent operators in fostering effective competition in the vehicle repair and maintenance market.

AT A GLANCE: NATIONAL ASSOCIATION – AICA

AICA, the Italian Association of Automotive Equipment Manufacturers, represents the industry professionals involved in the design, production and sales of plants, machinery and equipment for the assistance, maintenance and repair of means of transportation. This is an highly export-oriented sector that has achieved a worldwide leadership position thanks to its innovative products and the entrepreneurial abilities of many Italian SMEs which, in some cases, have reached multinational status. According to association estimates, in 2022 the sector exported products totaling 3.050 million Euros and the share designated for export represented 87,1% of the total turnover. In addition to foreign markets, the domestic market continues to have a prominent role, and in 2022 absorbed 450 million Euros. The sector managed to obtain in 2022 a total turnover (sales on the domestic and export market) of 3.500 million Euros. This turnover was achieved with a total number of employees estimated at 14.900. The sector's production is concentrated prevalently in the regions of Emilia Romagna, Veneto, Lombardy and Tuscany, which account for about 80% of the national total. The association acts as a guide and link for its 67 member companies. Although these companies account for a third of the total number of producers in this industry, they represent over 80% of the

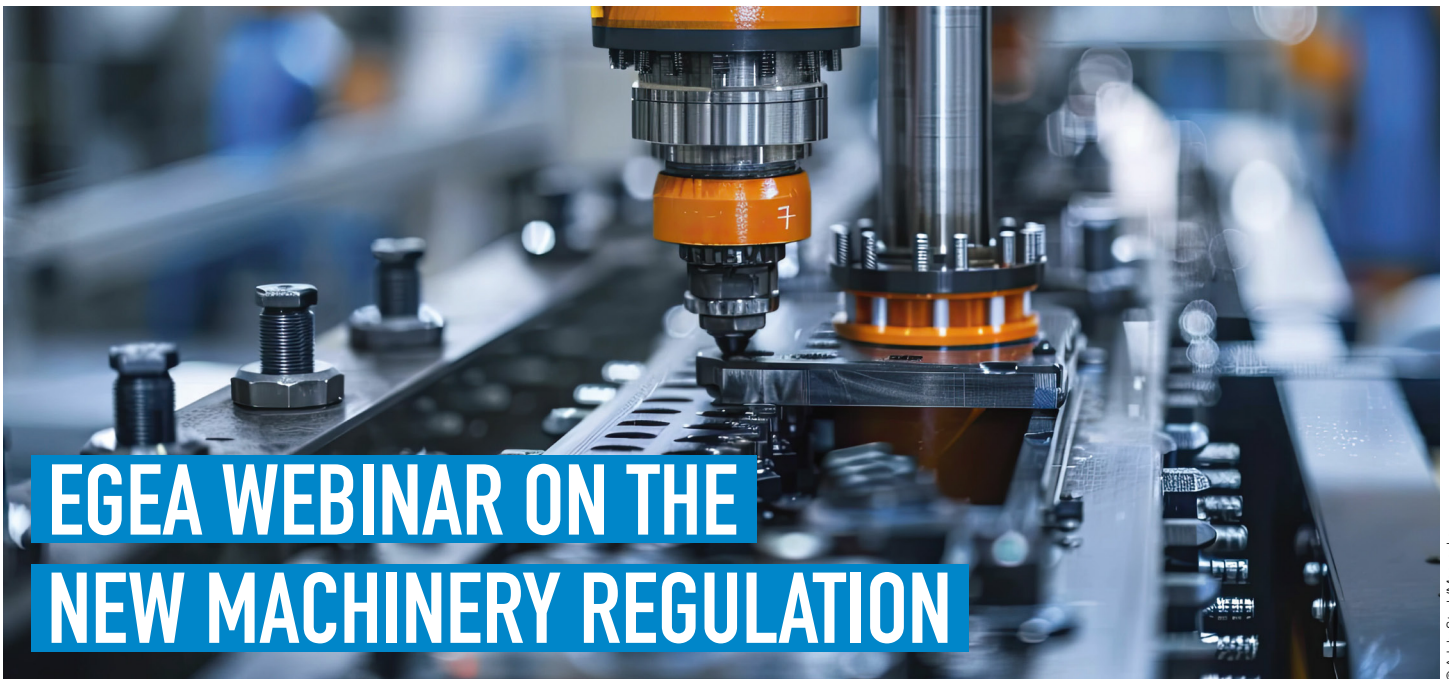
total turnover and the total employees in the sector. The mission of AICA is to voice the demands of members by reconciling the different characteristics existing within a highly diversified industry made up of both companies with specialized small-scale capabilities and larger groups that have opened up sales and production branches in the countries of highest strategic interest.

EGEA WEBINAR ON THE NEW MACHINERY REGULATION

On the 8th of February 2024, EGEA organized a successful webinar for its Members concerning Regulation (EU) 2023/1230 of The European Parliament and of the Council of 14 June 2023 on machinery and repealing Directive 2006/42/EC of the European Parliament and the Council and Council Directive 73/361/EEC. The key speaker was Mr Miguel Pelayo Munoz from BDO. Nearly 100 participants took part in the webinar. The new Regulation is already in force as of 2023 but will be applicable as of January 14th 2027. Mr Miguel Pelayo Munoz presented what are new Regulation (EU) 2023/1230 aims to cover as well as the most important issues related to the new regulation. Finally he presented conclusions which

are as follows:

- The new Regulation clarifies the distinction between machinery, related products and partly completed machinery.
- New regulation around the figure of substantial modification, as well as the obligation for a natural or legal person that carries out a substantial modification of machinery or a related product, shall be considered to be a manufacturer.
- Address the risks associated with the new digital technologies and it is specified that safety components should include not only physical devices but also digital devices.
- The different conformity assessment procedures have been revised in detail so that the obligations of each party are

better regulated, as well as a new evaluation procedure possibility.

- The manufacturer's obligations are regulated in detail and more strictly, and they are also regulated in those cases in which the obligations of manufacturers are applicable to importers and distributors.
- It opens the possibility of instructions for use and EU declaration of conformity in digital format.

FURTHER WEBINARS POSSIBLE

At the end of the webinar, there was a discussion session during which participants could ask questions. We would like to thank all participants for taking part in the webinar. We are also thinking about organizing similar webinars in the future.

In his work in Poland, he has represented entrepreneurs who operate PTI stations and diagnostic specialists who carry out technical tests. Among ot-

her things, he was responsible for contact with representatives of the government, parliament, public administration and other organizations, associations and institutions in the automotive industry. In his role, he prepared statements and position papers on issues important to the PTI industry and was actively involved in legislative processes. „It is a stroke of luck for EGEA members that Marcin Barankiewicz complements his extensive legal background with equally sound practical knowledge. After all, he is a lawyer and trained automotive technician,” says Beaujean.

FORWARD-LOOKING PROJECTS AWAIT

Numerous and difficult tasks await the new EGEA General Secretary. First and foremost, the reorganization of the PTI and the adaptation of technical testing and monitoring content to the latest vehicle technologies. The issue of fair and equal access to technical data and information, which is vital for the independent aftermarket (IAM), is also high on the agenda. This includes the practical implementation of the ECJ ruling of October 5, 2023 on the admissibility of secure gateways (SGW) for access to vehicle data from OBD interfaces. „We are also eagerly awaiting the discussions on the introduction of a sector-specific regulation for access to data, resources and functions of connected vehicles. These will form the basis for completely new business models in the aftermarket in the

future. I look forward to being able to support the EGEA and its members with my expertise on these forward-looking topics,” says Marcin Barankiewicz.



NGI - A FAST NEW WORLD

Workshop.Net, the networking standard for communication between ERP systems and workshop equipment devices, will be much faster to implement for new applications in future. asanetwork Managing Director Frank Beaujean and his developers have spent two years working on a new version of the network technology platform. Now the NGI (Next Generation Interface) platform is ready. The advantage for software providers and device manufacturers: NGI technology reduces the time required to implement new interfaces from several weeks to a few days. In future, the interfaces will communicate in a Workshop-Net session using web service technology. „Both the ERP systems (auto repair shop) / production systems (PTI) and the process control software of the workshop devices can now be installed in the cloud. Communication is protected by SSL certificates,” explains Beaujean. The NETMAN automatically translates the communication based on the old technology to the network participants with the new NGI technology! Legacy protection for all devices in the field with the „asanetwork” interface is guaranteed, as is the future viability of the „Workshop-Net” standard, for example for AI applications. → www.workshop-net.net
